- · Approx. 7 grievances appealed to DRT for 12/60-hour violations are coming inn resolved in the Union's favor. Now grievances are being appealed to DRT for management failing to comply with some portions of the resolutions.
- · Grievances for management conducting 1838c route counts outside criteria of Handbook M-39, have been resolved by DRT in the Union's favor and again the Union is appealing grievances up for management failing to comply. The Union is seeking enhanced remedies for the non-compliance.
- · Past practice grievances being filed for management changing case equipment, changing labels, taking away Vacation Hold equipment, Safety, Kermiting, Personal Items at the case, taking away Union Office. Most of these grievances are being impasse to Arbitration as none in management wants to go against those from Headquarters who created these grievances.
- · Grievances filed for improper Mandate and appealed to DRT, are coming back resolved in the Union's favor.
- · Grievances filed for Guarantee Time on Sunday Parcel delivery have been appealed to DRT.
- · Grievances filed for management delivering city mail, are at Formal Step A to be met on.

## Presidents Report AL Floyd

#### **President Renfroe announces Ballot Committee**

NALC President Brian L. Renfroe has appointed a Ballot Committee to monitor and observe the dispatch, receipt and tabulation of the ballots in the upcoming ratification election of the proposed 2023-2026 National Agreement between NALC and USPS.

Every active letter carrier eligible to vote in the contract ratification election will be mailed a copy of the changes in the proposed 2023-2026 National Agreement between NALC and USPS, along with the ballot materials. Eligibility to vote is defined by Article 16, Section 1 of the NALC Constitution which provides:

"Ratification shall be a mail referendum vote, and the ballot shall be mailed only to regular members of the NALC, as defined in Article 2, Section 1(a), excluding retirees, OWCP departees, and non-letter carrier regular members, as shown by the records of the National Secretary-Treasurer as of ninety (90) days prior to the date that the proposed agreement is reached."

The proposed agreement was reached on October 17, 2024. The NALC Constitution also provides that "membership acceptance or rejection of a proposed National Agreement shall be by majority of valid ballots returned by the voters." If the agreement is accepted, it will go into effect immediately. If the agreement is rejected, then, under the Postal Reorganization Act, the parties may continue bargaining or, ultimately, refer the dispute to an interest arbitration board. Under the law, decisions of the arbitration board are conclusive and binding upon the parties.
